Recent Experience

As an SIO I led many reactive, proactive and covert major crime investigations involved in Under-Cover Policing, Public Inquiries, Homicide, Serious and Organised Crime, Serious Misconduct Reviews, Miscarriage of Justice Reviews and Specialist Investigations.

I held senior leadership roles in Local Policing. I led the Criminal Investigation Departments (CID) in two separate London districts. In addition, at one of the BOCUs, I also retained the lead for Partnership, Emergency Response and Public Protection. I led many Critical and Major incidents with responsibility for a compliment of 1000 officers and staff.

I participated in and led various corporate leadership development programmes and acted as a Coach and Mentor to many officers and civilian staff. I took personal responsibility for developing all staff under my responsibility and specialised in developing new Detectives.

I was the MPS Communications Data Manager, linking in with other police forces and the Home Office in the use of 'Comms Data' to advance intelligence and aid investigations. I was also an accredited Authorising Officer for force-wide and national proactive operations and SIO in the investigation of serious misconduct allegations.

I wrote the MPS Counterterrorism Business Plan and established a leadership performance framework across Specialist Operations Commands. Within this command I qualified as a Strategic Firearms Commander.

Business Functions: Due to my business background, I led functions which involved Project Management (I was the Strategic Reports Manager for the National Olympic Policing Team 2012) and Finance (I oversaw an MPS budget of £8m for tasked corporate assets across London to combat serious crime patterns).
